

## OFFICIAL RULES NATIONAL CO-OP MONTH PRIZE DRAWINGS

Weekly and Grand Prize drawings (the "**Drawings**") are sponsored by Consumers Cooperative Association of Eau Claire, D.B.A. Mega! CO-OP, Mega! Holiday, Travel Stop, 1201 S. Hastings Way, Eau Claire, WI 54701 (the "**Sponsor**"). All federal, state and local laws and regulations apply. Void where prohibited. NO PURCHASE NECESSARY TO ENTER OR WIN.

DATES OF ENTRY: 12:00 a.m. on Monday, October 1, 2018, through 11:59 p.m. on Wednesday, October 31, 2018, Central Time.

**ELIGIBILITY:** Participation is open only to Mega! CO-OP members who: 1) present a valid Membership ID card; 2) are eighteen (18) years or older at time of entry; 3) are either the membership account holder, current spouse of the account holder or living with the account holder; and 4) are legal residents of Wisconsin. Employees of Sponsor, its respective subsidiaries or agents, immediate families (defined as parents, children, siblings, spouse and grandparents), and those domiciled with any of the foregoing are not eligible to enter. Sponsor and its representatives at participating locations have the right to determine a valid Membership ID card based on Mega! CO-OP guidelines.

Non-members may sign up for membership by completing a membership application. Existing members who do not possess a valid Membership ID card may request one online at megacoop.com or obtain a Card Request Form at participating locations. Sponsor is not responsible for lost, late, inaccurate, incomplete, damaged, illegible, or misdirected membership applications or Card Request Forms or for lack of possessing a valid Membership ID card.

Entries received after the date and time specified for the drawings will be deemed ineligible to win.

**HOW TO ENTER:** Eligible participants may enter in one of the following ways:

- 1. **ELECTRONIC ENTRY:** Scan a valid Membership ID card on any transaction. The "Entry" will be submitted electronically. Limit one electronic entry per transaction.
- 2. PAPER ENTRY / NO PURCHASE NECESSARY: Request a paper entry form under one of these conditions:
  - a. When opting not to make a purchase at any Sponsor location.
  - b. When payment is made at the gas pump at Mega! CO-OP Barron or a Mega! CO-OP Travel Stop facility at which Membership ID cards cannot be captured electronically.

The "Entry" will be manually submitted to the Sponsor prior to the drawing dates. A paper entry will not be issued if an electronic entry was already made at the same location during the same visit. Limit one paper entry per visit.

**WINNER SELECTION:** Winners will be selected as outlined below and must sign a Consent, Release and Waiver of Liability, Assumption of Risk, and Indemnity form before receiving their prize. The odds of winning are dependent upon the number of entries received.

<u>Weekly Winners</u>: One winner will be chosen per week from eligible entries collected at each of the 31 participating locations categorized by the Sponsor as "C-Store" or "Express" and that were submitted between 12:00 a.m. on the first day and 11:59 p.m. on the last day of each week:

Entries will be selected on the Wednesday or Thursday following each weekly drawing period. Eligible paper entries received during each weekly drawing period will be added to the weekly electronic entry files for that location. One eligible winner will be chosen for each participating location.

All weekly winners will be eligible for the Grand Prize Drawings.

<u>Grand Prize Winners</u>: On or about November 7, 2018, Sponsor will select one winner for each of the three grand prizes in order  $1^{st}$ ,  $2^{nd}$ ,  $3^{rd}$  from all eligible entries received during the dates of entry.

**PRIZE AWARDS:** The weekly winners will be notified by phone **on or about Thursday or Friday following each weekly entry period.** Grand prize winners will be notified **on or about November 9, 2018**. Sponsor will make pick-up arrangements with the winners, and the winners will need to sign an Affidavit (defined below) before any prize will be awarded. The membership account for a winning entry must have a current and working phone number. If phone number is not available, another entry will be selected.
